Scope of work note #2 states we are furnishing HM frames and HM & WD doors with all related hardware. But scope item # 7 says Install Only. 2.	The metal panel scope does not include the rainscreen HCi hat channels. Are we supposed to include those in our bid or is the drywall contractor also handling those?	10-22-19	The HCI girt system should be included in the panel install scope for coordination of connections and engineering	10-22-19 NS

3.	Will sheet metal flashing at the base of the metal panel that fastens behind the insulation like 3/A5.15 be furnished and installed by the Drywall contractor?	10-17-19	Flashing at the base is part of the metal panel BP #71.	10-22-19 NS
4.	BP#71 metal panels says we are not to include the insulation behind our metal panel but I don't see where any other trade is picking up this insulation. 5.	Please confirm if we need extrusions for the metal panels. scope sheet calls for extrusions, spec calls for trim made of the same material as the metal wall panels (22g).	10-22-19	Metal trim can be of same material as the panels. Extruded aluminum trim is not required.	10-22-19 NS

Notes 40,41,&42 • Stainless steel column wrap? Note 28 I assume we have the lockers in Room 1- 137 note 37, as we have all division 10.		 Signage? NOT IN BP 72 Scope Wire mesh partitions? Note 21 NOT IN BP 72 Scope Folding partitions? Notes 40,41,&42 NOT IN BP 72 Scope, make sure you are referencing the dash line that divides BG 7 from BG 10. Stainless steel column wrap? Can you add this flatness requirement to the concrete spec for the wood athletic flooring area so we know that the concrete will be flat. 	1. On sheet A10.02B.b, the South Balcony, 2-303, calls for SV-1. There is no finish break given for this product at this area as the plan cuts off north of the stairs. Does this product continue into the West Balcony 2-304? Please clarify	That is a typo. The south balcony does not get any floor finish or wall base.	10-22-19 NS
