The Policy Committee of Community High School District 99 met on Monday, May 23, 2016, at the Administrative Service Center. The meeting was called to order at 4:00 p.m.

The minutes of the December 21, 2015 meeting were reviewed and approved.

The following polices had revisions recommended by PRESS in its Update Memo. Revisions were in response to legislation, new public acts, and feedback. The policies will be brought forward for first reading in June 2016. The Committee endorsed accepting the changes recommended by PRESS to the following policies:

Mr. Theis explained that during a recent Reginal Office of Education (ROE) audit of the District, policy **7.20**, **Harassment of Students Prohibited**, was found to be out of compliance. Mr. Theis reviewed the changes recommended by the ROE auditor. The Committee endorsed accepting the changes. The policy will be brought forward for first reading in June 2016.

The Committee reviewed the policies that pertain to district and building level administrators and makes the following recommendations. The policies will be brought forward for first reading in June 2016.

- Deletion of policy 3.57, Director of Network Infrastructure; the administrative position no longer exists.
- Addition of policy 3.58, Director of Communications and policy 3.59, Business
 Manager; there were no policies for these positions.

- Changes, as noted, to the following policies:
 - 3.40 Superintendent of Schools Replacement of the first paragraph of the District
 99 policy with the first paragraph of the PRESS policy.
 - 3.60 Administrative Responsibility of the Building Principal and Associate/ Assistant Principals – Remove references to Associate/Assistant Principals.
 - o **3.61 School Building Administrators other than Building Principal** Remove the reference to *Director of Buildings and Grounds;* the position no longer exists.
