Upon the Secretary's roll call, Members Pavinato, Davenport, Renner, Pavesich and Beckman voted AYE. The Vice President declared the motion carried.

## 2. RECONVENE TO REGULAR SESSION

The meeting was reconvened in open session with the following members of the Board of Education in attendance: Terry Pavesich, Vice President/President Pro Tempore; and Members Julia Beckman, Deb Boyle, Mike Davenport, Don Renner and Rick Pavinato. President Nancy Kupka and was absent.

Dr. Thiele shared enrollment projections based on a study recently received from demographer Dr. John Kasarda. Dr. Thiele stated, based on the projected drop in enrollment for 2017-2018, the District would need 9.2 less FTE in 2017-2018 than in 2016-2017, but since there were 13 retirements, there would be no impact on currently employed staff. Dr. Thiele stated the administration was recommending a 21.8:1 Staffing Ratio for 2017-2018, the same ratio that has been in place the last few years. Mr. Theis stated the Board would vote on the Staffing Ratio at the January 23 Board Meeting.

# 4. RESOLUTION OF THE BOARD OF EDUCATION OF COMMUNITY HIGH SCHOOL DISTRICT 99 OPPOSING DETACHMENT OF PROPERTY FROM DISTRICT 99 AND ANNEXATION TO DISTRICT 86
