

February 14, 2022

The Board of Education, Community High School District 99, met in Special Session with Action Item at 6:30 p.m. on Monday, February 14, 2022 the Administrative Service Center.

President Kupka appointed Aja Johnson to serve as the secretary pro tem.

Upon the Secretary pro tem's roll call, the following Board members answered present: Nancy Kupka, President; Mike Davenport, Vice President, and Members Christopher Espinoza, Jennie Hagstrom, Terry Pavesich and Joanna Vazquez Drexler. Member Sherell Fuller was absent.

Also present were Hank Thiele, Superintendent; Gina Ziccardi, Associate Superintendent; Rob Lang, Assistant Superintendent for Staff Services; Jeree Ethridge, Assistant Controller; Jill Browning, Director of Communications; Courtney DeMent, North High Principal; Ed Schwartz, South High Principal; Student Board members Scarlett O'Hara and Jade Toledano; and Aja Johnson, Secretary pro tem.

There were seventeen visitors. A copy of the Visitor Roster is attached.

#### **1. 2021-2022 RETURN TO IN-PERSON INSTRUCTION PLAN**

Dr. Thiele read an opening statement expressing appreciation for the communities' involvement and the work of the Board, who are volunteers. He stated the Administration will follow the Board's direction.

Dr. Thiele reviewed the COVID mitigation timeline starting in July of 2021, and noted that on August 2, 2021 the Board put in place mitigation efforts of face coverings and contact tracing, consistent with the recommendations of health agencies. Dr. Thiele stated the Board's rules were in place prior to the Governor issuing his Executive Order requiring masking. On February 4, 2022, a temporary restraining order was issued preventing the State from enforcing the Governor's rules for those Districts named in the lawsuit, which included District 99. Therefore, according to Dr. Thiele, the mitigation measures approved by the Board prior to the Executive Order are in effect, which include face coverings.

Mr. Schwartz, speaking on behalf of himself and Dr. DeMent, stated in two weeks the Governor is removing the mask mandate outside of schools and it is time to transition to making masks optional.

Dr. Thiele presented the Administration's recommendations, to be effective February 18, which included: following all Federal and State laws (which currently includes masking on buses and the potential outcome of pending or future litigation); sick students and staff will be expected to stay home; contact tracing/exclusions will end; and mask wearing will be respectfully recommended. Dr. Thiele stated the District would provide two KN95 masks to students and noted universal masking would still be required on transportation, which includes buses and in Driver Education cars, per Federal mitigation measures, and in the Health offices.

## **2. RECEPTION OF VISITORS – PUBLIC COMMENT**

Debby Robertson, Ana Guido, Deb Davero, Jordyn Raymond, Erica Rausch, Brooks Johnson, Kevin Kuster, Noel Manley, Barbara Allen, David Pittinger, Steve Peters, Ben Pittinger, Hugh Califf, Isabella Folise, Sydney McCormick, Carolyn Gugliemo and Lilly Roche addressed the Board in support of making masks optional.

Dr. Thiele noted 235 Public Comments were been received via the online Google form, which was opened the day the meeting was announced, and the Board has had an opportunity to review those comments. He stated there were comments both in favor of continuing masks and making masks optional. Dr. Thiele stated the comments received would become a part of the Meeting Minutes.

## **3. MITIGATION MEASURES RELATED TO THE 2021-2022 RETURN TO IN-PERSON INSTRUCTION PLAN**

Member Hagstrom moved and Member Davenport seconded the motion for the Board of Education the amend the mitigation measures related to the 2021-2022 Return to In-Person Instruction Plan approved at the August 2, 2021 Board of Education Meeting as presented.

Members of the Board expressed their thoughts and rational on whether or not masks should become optional, and stressed how much they care about the well-being of the students of District 99.

Student Board Members emphasized students and staff need to be respectful of the choices people make and both shared they would likely continue to wear masks.

Dr. Thiele stated the Administration will follow and carry out whatever rules the Board establishes and urged Board members to vote based on what they felt was best for students. He offered an alternative recommendation, for the Administration's recommendations to be effective February 28, instead of February 18, noting there is no reason for students to mask once adults are no longer required to.


Member Hagstrom accepted the recommendation to have the new protocols and mitigation measures be effective on February 28. Member Davenport seconded the motion.



Dr. Thiele reiterated that masks would be required until February 28. Board members expressed concerns about how bullying would be addressed. Dr. Thiele stated students who felt bullied should go to a trusted adult and the Deans/Administration would follow through.

There being no further business or discussion, Member Pavesich moved and Member Davenport seconded the motion that the meeting be adjourned. Upon the unanimous voice vote of the six members in attendance, the President declared the motion carried. The meeting adjourned at 9:18 p.m.

Since there are unjust restrictions in place and I likely will not be able to actually go inside for the meeting on Feb 14th, I am submitting my comments here to the D99 Superintendent and School Board.

We are disgusted with the fact that the school has decided to completely ignore the TRO put in place on Feb 4th by Judge Grischow and that D99 continues to dictate that students wear a mask in order to get an education. Many kids have been exercising their legal rights to a full in class education, without the restriction of a face covering. Instead, they showed up for school and were segregated from their classmates and denied access to the learning taking place in the classroom. This action has caused them to fall behind in classes and be separated from some of their friends, when all they wanted to do was finally be comfortable in school as well as fully see and communicate with their fellow classmates. For a school that supposedly bends over backwards to make sure everyone is welcome and equal, you had no problem kicking kids out of class and making them feel unwelcome and unequal.

One of the most important decisions that you will make tonight is whether to require masks at Downers Grove North and Downers Grove South high schools. The answer is clear: you must vote to continue following the health experts and require students to wear masks in schools.  
The health experts know what they are talking about. If you continue to require masks to be worn by every student, less people will be infected by COVID and consequently, less people will be sent home, affecting their learning significantly. Masks do not kill people, but COVID does.  
First, we need to discuss public health experts and their opinions on the matter. It has been made clear, both by the CDC(Centers for Disease Control and Prevention) and the IDPH(Illinois Department of Public Health), that schools should still require their students and staff to wear masks.  
Secondly, by requiring and enforcing the wearing of masks by students and staff, less people will be forced to quarantine after becoming infected with COVID-19. If we went mask optional, many people would cease to wear their masks, causing many people to be afflicted with COVID-19, forcing them to quarantine. This will lead to a severe lack of learning, far greater than what the lack of masks would compensate for, for the students who contract the virus and for those whose teachers become ill.  
Finally, COVID has killed far more people than masking ever has. In the US, more than 917,000 deaths from COVID-19 have been reported and there are almost certainly far more. In Illinois alone, there have been more than 35,000 deaths from COVID. That's more than the entire population of Woodridge and nearly three quarters of the population of Downers Grove! This is with taking preventative measures and without social distancing, masking, or vaccinations, there would certainly be far more. Thus far, no deaths from wearing a mask have been reported.

We would like to make our thoughts on this topic known for being in support of the removal or optional masks for all students and employees of Downers Grove Community High School District 99.

As reference, Downers Grove District 58 has just lifted their mask policy, effective 2/14/22 and COD District 502 has lifted theirs, effective 2/28/2022.

Below is information regarding the change in policy regarding masks from both Dist. 58 and Dist. 502:

February 10, 2022

Dear District 58 Families and Staff,

The District 58 Board of Education held a Special Meeting on Thursday, Feb. 10 at Downers Grove Village Hall. The meeting comprised a Return to Learn update from Superintendent Dr. Kevin Russell, a one-hour public comment opportunity, and a Board discussion on District 58's COVID-19 mitigations.

Ultimately, the Board voted to adopt a resolution that makes the following changes to District 58's COVID-19 mitigation plan, effective Monday, Feb. 14:

1. District 58 recommends, but will not require, students and staff to wear a mask at school. Masks are still required on District transportation, per federal mandate.
2. District 58 will not require "close contacts" to stay home from school.
3. District 58 will not require unvaccinated District staff to submit to weekly testing.

Please note: The Temporary Restraining Order (TRO) against Governor Pritzker's mask mandate has already been appealed, and motions to stay the TRO have been filed. It is possible that the TRO will be overturned. If the TRO is overturned, District 58 will immediately review and follow the court decision, and this might mean that District 58 will require masks in schools again. School districts that ignore or refuse to comply with state mandates risk losing accreditation, state funding and insurance coverage. This is not a risk District 58 is willing to take.

The updates outlined above will begin on Monday, Feb. 14 to give staff time to prepare and to have conversations with students. We ask all families and staff to please respect this decision and to continue to follow all COVID-19 mitigation measures, including wearing masks, while at school on Friday, Feb. 11.

Although masks will not be required starting next week, District 58 still strongly recommends all students, staff and school visitors wear a mask, in alignment with Illinois Department of Public Health guidance. The guidance also recommends a layered approach to removing mitigations, which is what District 58 will do. District 58's instructional spacing will remain at 3 feet, and lunch and recess will be handled in the same way as they are today. In addition, staff will maintain 6 feet of distancing in instructional spaces to the greatest extent possible. The District will also provide additional PPE, including KN95 masks, to staff upon request.

Finally, District 58 asks all families and staff to please respect one another's mask choices and to treat each other with kindness. District 58 teaches its students to be kind and respectfully requests everyone to lead by example.

Dear President Kupka, Board Members and Dr. Thiele:

I want to commend you on how you have led the District over the past two (2) years. I know and understand how hard your role in leading the District over these confusing and challenging times must have been and continue to be. I am writing to you in furtherance of staying the course and not flailing in the winds of political pressure, which often comes from the loudest voices, but, ironically, also the least informed.

I do not mean to presume what your actions will be at the upcoming special meeting on February 14th, but, from what the public can view, there will be a motion to amend the Mitigation Measures adopted by the Board at its workshop on August 2, 2021. Given the actions of some of the surrounding school districts I am a tad concerned as to the purpose and potential outcome of this special meeting.

At the 8.2.21 workshop, I understand that the Board voted to adopt the following Mitigation Measures: 8 period day, mask wearing following CDC/IDPH/DCHD guidelines, with the recommendation updated each Friday; and continuing to offer opportunities for students, staff and the community to be vaccinated. Also at said workshop, it was determined the best way to keep students at school as much as possible and to keep everyone safe was to follow federal, state and local guidance and to require universal masking indoors when the DuPage County Transmission Level is in the Substantial or High Transmission Level. The Board agreed to follow CDC guidance and use the county numbers to determine Transmission Level, which, as of the time of this writing, remains high.

As a parent and community member, I am very proud of how this policy has worked to date and hope and implore that these mitigation measures remain in place. Basing your Mitigation Measures on state and federal guidance from CDC/IDPH/DCHD is clearly the best route to follow. How can anyone, who is not otherwise motivated for political reasons, question your judgment if you continue to follow the lead of these organizations in these matters? As a school district you do not have the leisure of relying on epidemiologists who can help to guide your decision making independent of these organizations. Instead, you are reliant on the experts who study transmission of COVID-19 both nationally and locally. This makes perfect sense. I would hope and expect that you will continue to follow this guidance, and, as transmission levels subside, you can modify your Mitigation Measures accordingly, as you reasonably decided last August.

I am concerned that if you turn from this well reasoned and principled means of guiding your decision-making through this pandemic, in light of the district court's ruling from last Friday and ensuing nonsense that followed this week, you could jeopardize your integrity and ability to lead the District through the remainder of this pandemic (and likely endemic).

The facts remain true that masks protect against the spread of transmission of COVID-19, the CDC continues to recommend masks be worn in schools (although this could certainly change in the future), not all students/staff are vaccinated, some students who have certain health conditions remain vigilant to prevent contracting COVID-19 to preclude any serious health implications should they contract the same, and we do not know what future variants may be forthcoming or what transmission and mortality rates a new variant may hold. I trust that you can see this would be very difficult and would call into question your leadership and credibility in the community's eyes; whereas, if you continue to hold to following the science, at least you will have maintained the integrity that you have preserved to date.

I trust that under the strong leadership of Dr. Thiele and Dr. Kupka, the Board will make the right decision in this regard.
