#### 3. STUDENT PERSPECTIVES

South High Student Council members Ben Adams, Erica Alves, Rakiya Johnson, Kelly Lyons, Jillian Paladino, Carl Reifsteck III and Rhaya Truman shared information on the Halloween Fun Fair and Daddy Daughter Dance, two of the activities Student Council coordinates that are open to the community.
