The Parent-Teacher Advisory Committee of Community High School District 99 met at 6:04 p.m. on Thursday, May 20, 2020. Per Executive Order 2020-07, and the Gubernatorial Disaster Proclamation Issued by the Governor on March 16, 2020, the meeting was held with all attendees participating remotely. There was no one physically present.

The following were present: Board Members Mike Davenport and Joanna Vazquez Drexler; Scott Wuggazer; Assistant Superintendent for Student Services; Gina Ziccardi, Associate Superintendent for Student Learning; and Juli Gniadek, Secretary.

1. INTRODUCTIONS AND PURPOSE OF THE MEETING

Scott Wuggazer welcomed those in attendance, and invited attendees to introduce themselves. He shared the Parent Teacher Advisory Committee meets every year and the topic changes from year-to-year. Mr. Wuggazer reviewed the agenda and thanked everyone for attending.

2. BEHAVIOR INTERVENTION PROCEDURES

Scott Wuggazer shared what a Behavior Intervention Plan (BIP) is and noted the District is updating its Behavior Intervention Plan procedures for students with an IEP. He stated there are many resources from both the Illinois State Board of Education (ISBE) and the United States Department of Education being used.

3. CONSOLIDATED DISTRICT PLAN

Gina Ziccardi stated the Consolidated District Plan is submitted to ISBE every year, following Board of Education approval, and encompasses the Title I, II, III, IV and IDEA grants. Ms. Ziccardi provided a summary of the requirements of the Plan, needs identified through the review of data and input by various stakeholders, and some of the interventions being used to address those needs. Ms. Kristee Toth, South High Special Education Teacher, and Dr. Karen Taylor, North High Associate Principal, provided information on the PATH program, a new intervention for the 2020-2021 school year, which students may voluntarily participate in instead of receiving an out-of-school suspension.

4. CLOSING REMARKS


Mr. Wuggazer thanked the parents and staff for attending and for providing their insights. He stated he will be sending a follow up Google Form so participants may provide additional feedback, if they wish.
